As lawful consideration for participating in the classes, I, for myself, my heirs, executors, administrators, legal representatives, successors and assigns (the Releasing Party"), hereby waive, release, discharge and agree not to sue and to indemnify, defend and hold harmless the Peoria Obedience Training club, and their officers, board members and instructors, (the "Released Party") from any and all injuries, losses, claims and damages to any person or person of any nature whatsoever, including claims arising from the Released Party's own negligence, and all costs associated therewith, including attorney's fees, court costs and consultant fees, arising from my participation in the Classes.
