

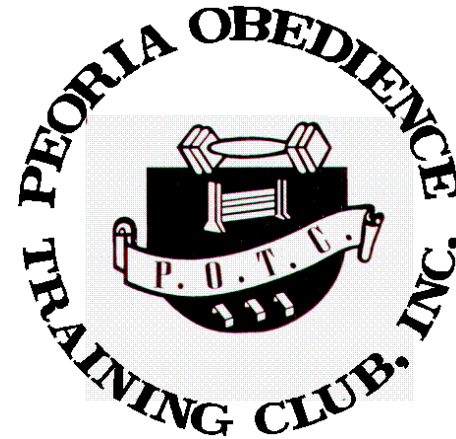

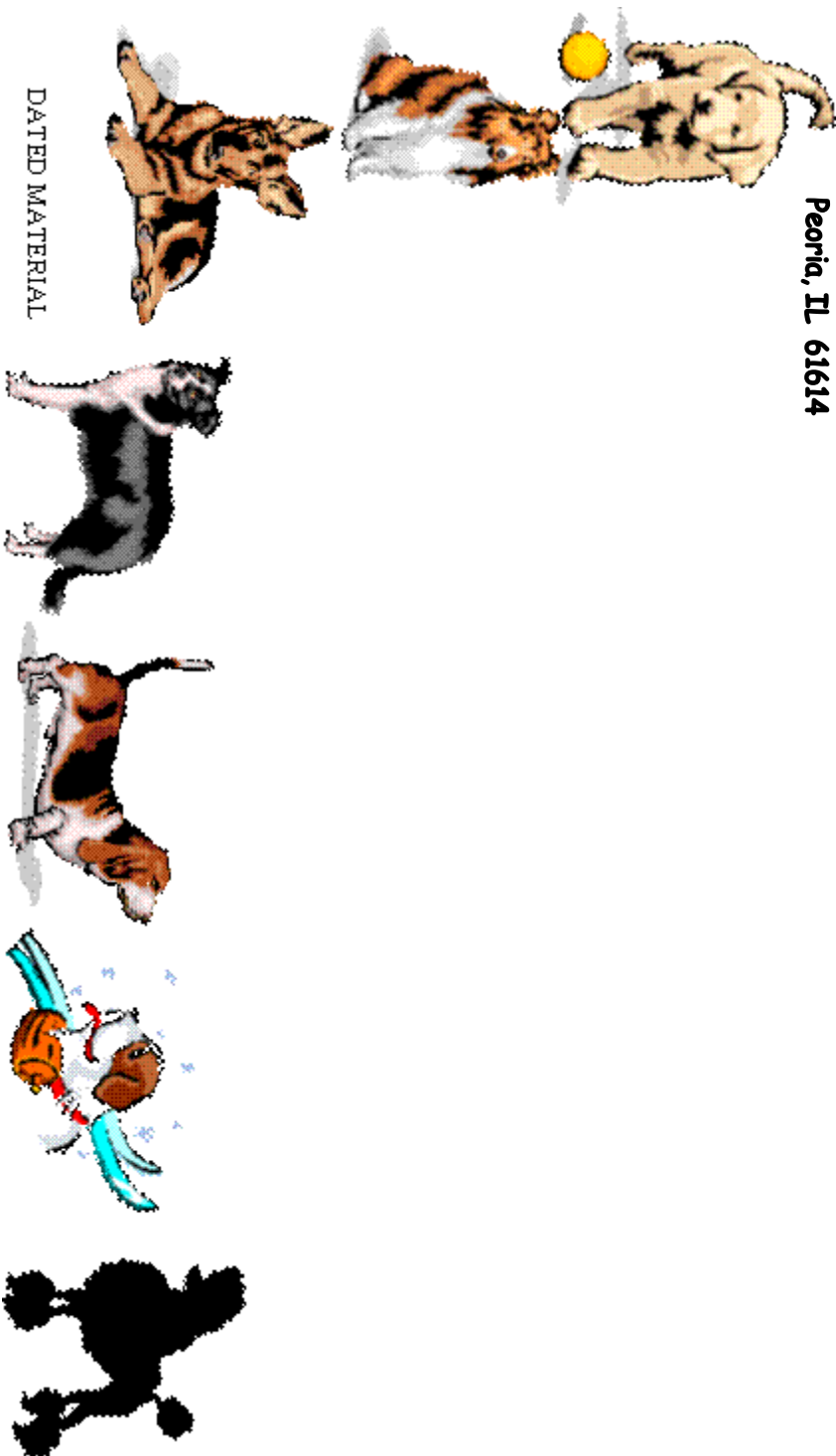

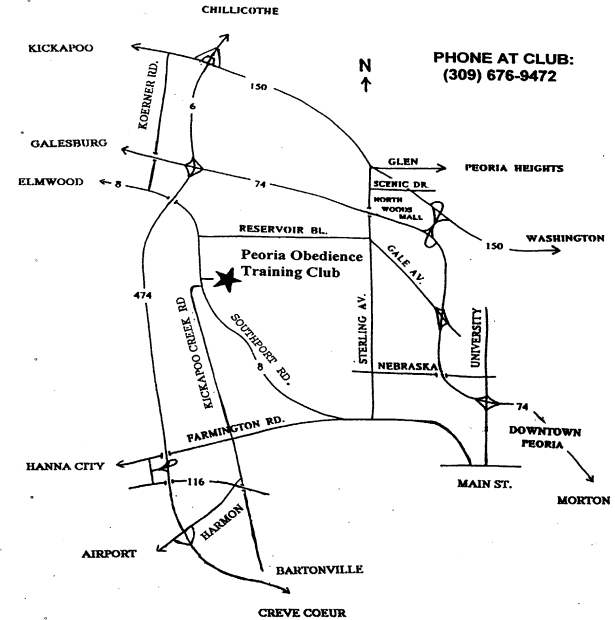

ALL ROADS LEAD TO POTC

DIRECTIONS TO THE TRIAL SITE

Note – There is now an exit at I-74 and Sterling Avenue.

From I-55 - Take I-74 west to Peoria. Exit at Sterling Ave. Turn left onto Sterling to Reservoir Blvd. Turn right on Reservoir and proceed to Route 8. Turn left onto Route 8 and continue on for about 1/2 mile. Turn left at POTC sign.

From West - Take I-74 east to Peoria. Exit at Sterling Ave. Turn right onto Sterling to Reservoir Blvd. Turn right on Reservoir and proceed to Route 8. Turn left onto Route 8 and continue for about 1/2 mile. Turn left at POTC sign.

From Route 150 (War Memorial Drive) - Go south on Sterling to Reservoir Blvd. Turn right on Reservoir and proceed to Route 8. Turn left onto Route 8 and continue for about 1/2 mile. Turn left at POTC sign

Show location is available to exhibitors at 7:00 a.m. the morning of the Trials. Saturday, August 18 and Sunday, August 19, 2018. Dogs are not required to be at this trial until their scheduled time of judging and may be excused when not needed for further judging. Judging begins at 9:00 a.m. both days.

ENTRY FEES:

ENTRY FEE is \$25.00 for the first entry of each dog and \$18.00 each additional entry of the same dog in the **same** trial. There are **two different trials on Saturday and one trial on Sunday**. No discount for cross entries of trials. Fees include the \$.50 AKC Recording Fee on the first entry of a dog.

Non-regular Pairs Class is considered one entry (2 dogs/entry).

ENTRIES CLOSE at the office of the Trial Secretary, Wednesday, August 2, 2017, or when limits are reached if prior to this date, after which time entries will not be accepted, canceled, altered or substituted, except as provided for in Chapter 14, Section 6 of the Dog Show Rules. Judges limited to 8 hours of judging per day.

NOTICE

A Peoria County ordinance requires that all dogs shall have been vaccinated against rabies within the past year.

BITCHES COMING INTO SEASON after closing date will be granted a refund of entry fee providing club is notified in writing by a veterinarian within 7 days after the date of trials.

Peoria Obedience Training Club reserves the right to cancel due to extreme weather conditions.

CHAPTER 1, SECTION 21 OF AKC RALLY REGULATIONS

The Rally Regulations require that dogs be judged in catalog order to the extent practical, without holding up the judging. A judge need not mark absentees in the Judge’s Book until the end of the class. Judges are not required to wait for dogs.

CHAPTER 2, SECTION 11 OF RULES APPLYING TO DOG SHOWS

The American Kennel Club will collect a \$3.00 Event Service Fee for the first entry of a dog and a \$3.00 service fee for each additional entry of the same dog in the regular and non-regular recordable single entry classes, in all AKC licensed and member club events. The current 50 cent recording will continue to be collected.
