**From I-55** - Take I-74 west to Peoria. Exit at Sterling Ave. Turn left onto  
Sterling to Reservoir Blvd. Turn right on Reservoir and proceed to Route 8.  
Turn left onto Route 8 and continue on for about 1/2 mile. Turn left at POTC  
sign.

**From West** - Take I-74 east to Peoria. Exit at Sterling Ave. Turn right onto  
Sterling to Reservoir Blvd. Turn right on Reservoir and proceed to Route 8.  
Turn left onto Route 8 and continue for about 1/2 mile. Turn left at POTC sign.

**From Route 150** (War Memorial Drive) - Go south on Sterling to Reservoir  
Blvd. Turn right on Reservoir and proceed to Route 8. Turn left onto Route 8
