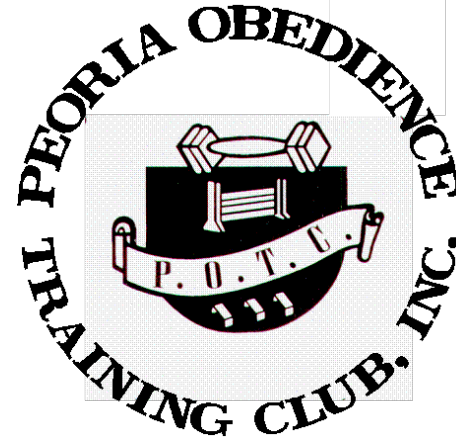

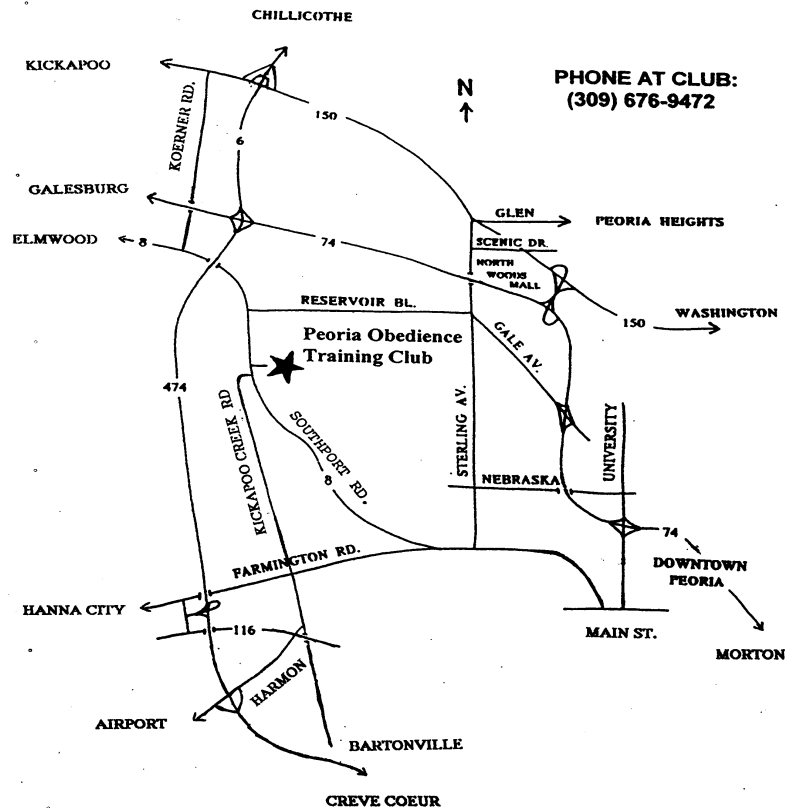

Show location is available to exhibitors at 7:00 a.m. the morning of the Trials. Saturday, September 16 and Sunday, September 17, 2023. Dogs are not required to be at this trial until their scheduled time of judging and may be excused when not needed for further judging.

ENTRY FEES:

ENTRY FEE is \$25.00 for the first entry of each dog and \$18.00 each additional entry of the same dog in the **same** trial. **There are two different trials on each day..** No discount for cross entries of trials. Fees include \$3.00 Event Service Fee on the first entry of a dog, the \$.50 AKC Recording Fee on the first entry of a dog and \$3.00 Service Fee for additional entries of same dog in each trial.

ENTRIES CLOSE at the office of the Trial Secretary, Wed. August 30, 2023, or when limits are reached if prior to this date, after which time entries will not be accepted, canceled, altered or substituted. Judging limited to 8 hours per day per judge.
