\*\*\*\*DIRECTIONS TO THE TRIAL SITE\*\*\*\*

**From I-55 –** Take I-74 west to Peoria, Exit at Sterling Ave. Turn left onto Sterling to Reservoir Blvd. Turn right on Reservoir and proceed to Route 8. Turn left onto Route 8 and continue on for about ½ mile. Turn left at POTC sign.

**From West -** Take I-74 east to Peoria. Exit at Sterling Ave. Turn right onto Sterling to Reservoir Blvd. Turn right on Reservoir and proceed to Route 8. Turn left onto Route 8 and continue for about 1/2 mile. Turn left at POTC sign.

**From Route 150 (War Memorial Drive) -** Go south on Sterling to Reservoir Blvd. Turn right on Reservoir and proceed to Route 8. Turn left onto Route 8 and continue for about 1/2 mile. Turn left at POTC sign.
