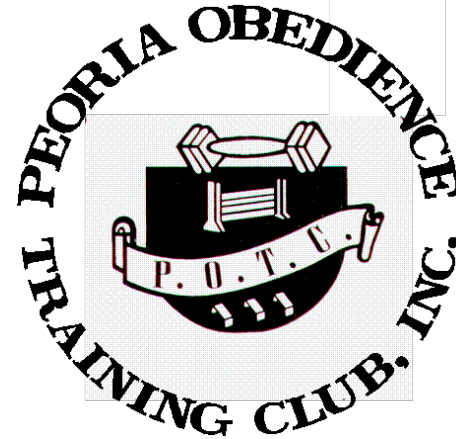

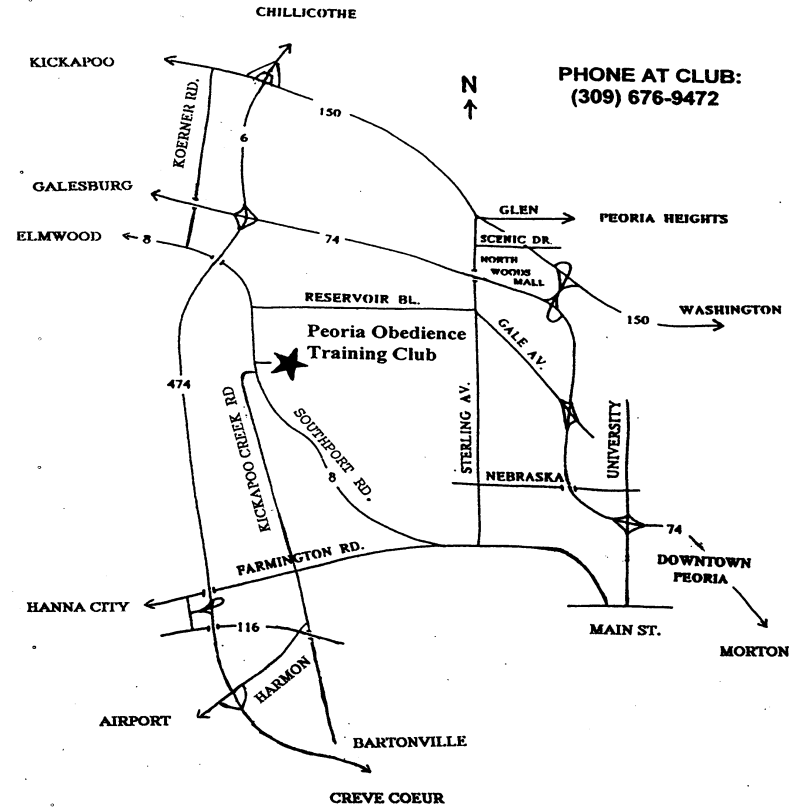

New this year is 2 rings and 2 judges. For each trial Previously we had 3 rings and 3 Judges

Show location is available to exhibitors at 7:00 a.m. the morning of the Trials. Saturday, September 14 and Sunday, September 15, 2024. Dogs are not required to be at this trial until their scheduled time of judging and may be excused when not needed for further judging.

ENTRY FEES:

ENTRY FEE is \$25.00 for the first entry of each dog and \$18.00 each additional entry of the same dog in the **same** trial. **There are two different trials on each day..** No discount for cross entries of trials. Fees include \$3.00 Event Service Fee on the first entry of a dog, the \$.50 AKC Recording Fee on the first entry of a dog and \$3.00 Service Fee for additional entries of same dog in each trial.

ENTRIES CLOSE at the office of the Trial Secretary, Wed. August 28, 2024, or when limits are reached if prior to this date, after which time entries will not be accepted, canceled, altered or substituted. Judging limited to 8 hours per day per judge.

NOTICE

A Peoria County ordinance requires that all dogs shall have been vaccinated against rabies within the past year. Per AKC - Exhibitors should follow their veterinarian’s recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

BITCHES COMING INTO SEASON after closing date will be granted a refund of entry fee providing club is notified in writing by a veterinarian within 7 days after the date of trials.

CHAPTER 2, SECTION 11 OF RULES APPLYING TO DOG SHOWS:

The American Kennel Club will collect a \$3.00 Event Service Fee for the first entry of a dog and a \$3.00 service fee for each additional entry of the same dog in the regular and non-regular recordable single entry classes, in all AKC licensed and member club events. The current 50 cent recording will continue to be collected.

NOTICE TO EXHIBITORS
